
- Default IP address: **192.168.1.30**

- Default admin password: **123456** (only for first login and should be changed to a strong one with at least 8 characters including upper and lower case letters, digits and symbols to enhance account security.)


▶ LEDs

LED	Description
RUN(Operation)	<ul style="list-style-type: none"> • Steady on: Normal. • Blinks: Starting up.
NET(Network)	Steady on: Connected to network.
CLOUD	Steady on: Connected to cloud server.
HD(Hard disk)	<ul style="list-style-type: none"> • Steady on: No disk, or disk is abnormal. • Blink: Normal, reading/writing data.

▶ Ports and Interfaces(Take One Model for Example)




Disk Installation



Please contact your dealer for compatible hard disk models. Prepare 1# or 2# Phillips screwdriver.

 Disconnect power before you start. Use antistatic gloves or wristband throughout installation.

The photos are for reference only. The example shows how to install a 1-HDD device. Installation is similar for a device with 2 or more HDDs.



1. Loosen screws on the rear and side panels and then remove the cover.



2. Connect one end of the data and power cables to the hard




3. Tighten the screws halfway.

disk.



4. Align screws with screw holes on the bottom plate, and then slide the hard disk in position.



5. Fasten the screws.



6. Connect the power cable to the motherboard.



7. Connect the data cable to the motherboard.

8. Replace the cover and fasten the screws.

Connect Devices

1. Connect the device to a monitor with a VGA/HDMI cable (sold separately).
2. Connect a USB mouse to the device.
3. (For analog camera only) Connect the camera to a Video In interface with a coaxial cable. Skip this step if you are connecting an IP camera.

4. Connect the network cable.

 Normally a network switch is used to connect the device and IP cameras with one network.

5. Connect power.

Startup

Verify installation and cable connection are correct. Connect power to start the device.

Add Cameras

Analog Camera

Please prepare a coaxial cable (sold separately). Connect BNC connectors to the camera and the device.

 Please refer to PTZ descriptions for presets if the analog camera is connected to the PTZ via RS485.

IP Camera

Make sure the IP camera is connected to the network.

1. Click **Menu > Camera > Camera**.
2. Click  to add the camera.

 To search a specified network segment, click **Search Segment**.

Normally all discovered cameras can be added. If the status is , it means the camera has been added successfully and is ready for live view; otherwise, please check network and make sure the username/password are correct. Click the edit button to modify if necessary.

▶ Change Camera Type

By default the device can connect 2 IP cameras. To connect more IP cameras, click **Menu > Camera > Camera > Camera Type** and change camera type to digital. An analog camera cannot be connected when the camera type is set to digital.

▶ Recording and Playback

Recording

For analog camera: You need to manually enable the recording schedule for the camera (**Menu > Storage > Recording**).

 When recording schedule is enabled, the device still records even when no analog camera is connected.

For IP camera: A 24/7 recording schedule is enabled by default for all IP cameras. You may edit recording time and type at **Menu > Storage > Recording**.

Playback

Right-click a preview window and then choose **Playback** to view video recorded on the current day.

▶ Access Using a Web Browser

Access the device using a Web browser (e.g., Internet Explorer) from a connected computer.

1. Enter the device's IP address in the address bar and then press **Enter**. Install the plugin as prompted. Close all Web browsers when the installation starts.

2. Open the Web browser and log in with the correct username and password.

Access from Mobile App

Install the app on your mobile phone and sign up for a cloud account. For details please contact your dealer.

Connect your device to a router with Internet connection, and connect your mobile phone to the router's Wi-Fi network. Scan the QR code on the device with the mobile app to add the device.

Shutdown

Click **Menu > Shutdown**.

 Do not disconnect power when the device is operating. A sudden power failure may cause device damage and loss of data.
